A motion was made by Chairman Mowatt, seconded and unanimously VOTED to approve the minutes of March 24, 2021 as presented.

### **REGULAR MEETING:**

1. Shree Ganpati, Inc. d/b/a Westfield Spirit Shop, Asha D Patel, mgr, 440 Southampton Road, Westfield, MA requesting a pledge of license and inventory to Rockland Trust Bank.

The office manager stated that this request will be heard at the June meeting as the Licensee is still pending the submission of documents.

#### LATE COMMUNICATION:

1. Letter from Great Awakening Brewing Company, 77 Mill Street, Westfield, MA 01085.

The Office Manager stated that the licensee currently has a Farmer Brewery License with the ABCC and a Farmer Pouring Permit with the City to serve the beer they produce. They are looking to transfer to a Pub Brewery License with the ABCC and a Beer & Wine or All Alcohol Pouring License with the City so they can sell and serve their beer and other alcohol from other suppliers. They would like to hold the same licenses as Skyline. The application packet has been emailed to them. When they submit the application, the Commission could either deny the request or approve the request contingent upon receiving the Pub Brewery License from the ABCC. Once received the licensee would then turn in their farmer series pouring license for the new pouring permit they applied for.

### **ADMINISTRATIVE BUSINESS:**

- 1. The office manager stated that at the last commission meeting the commission approved the request of 287 North Elm Street for a section 15 All Alcohol Package Store License through the Special Act of the Legislature. The Licensee has decided to hold off at the moment to start the process. He will advise us when he is ready to move forward.
- 2. The office manager stated that she was going to inform the commission of the ABCC advisory issued on May 4, 2021 but Governor Baker just recently updated the COVID guidelines.

The office manager stated that she will be attending a zoom meeting that the ABCC is holding to discuss the new updated COVID guidelines.
